Admissions Procedures Kindergarten 2012-13

We want children to thrive in the SJCS environment; therefore, we seek a match between the school and each student. Four major factors are considered in making a decision for acceptance to our Kindergarten. These include:

- Chronological Age – Children who turn five by August 31st of the upcoming year are eligible for Kindergarten
- Readiness for our program
- Cognitive and social skills
- Large- and fine- motor development

The procedure for application to Kindergarten at SJCS is:

- Completion of the application, and payment of \$100 application fee, no later than **January 12, 2012**
- Completion of Request for Records and SJCS's receipt of Common Teacher Evaluation Form by January 12, 2012
- Your child's attendance at an assessment on January 22, 2012 or February 5, 2012

Children who would be a good match for our program, but for whom space is not available, will be put in a wait pool and offered a space, should one become available.
